From October 24-27, 2012, San Diego will be the site of the annual meeting of the National Conference of Bankruptcy Judges (NCBJ). The NCBJ includes in its membership nearly all of the federal bankruptcy judges in the United States. The NCBJ's annual meeting is the premier gathering of attorneys, academics, judges, investment bankers, and turnaround managers along with a variety of other restructuring professionals.

Some of the over 2,000 professionals attending this meeting have participated in many of the largest and most sophisticated bankruptcy cases filed in the U.S. and globally.
