3Ls/Recent Grads: Immigration Fellowship Opportunity in New York

The Cardozo School of Law's Kathryn O. Greenberg Immigration Justice Clinic is seeking two clinical fellows to start in Fall 2013. The Immigration Justice Clinic is an in-house year-long intensive clinic in which students represent immigrants in a variety of matters but primarily in deportation proceedings in the immigration courts and federal courts. The clinic's docket focuses on immigrants facing deportation because of encounters with the criminal justice system and more generally on immigration enforcement issues.
